## MHC MEDICAL STAFF PROVIDER LIFE SUPPORT REQUIREMENTS (April 2024)

- -Deadlines listed apply to all existing providers subject to the new systemwide requirements being phased in between 2024-2025.
- -Any new provider coming on staff will have a six-month grace period from Board approval date to obtain all required certifications (with the exception of those required to issue sedation privileges).
- -Administrative Staff providers have a BLS requirement and follow the deadline date for their respective specialty.
- -Providers who are 100% telemedicine are exempt.
